In Preparation

“Islands of Memory: The Literary Politics of Traumatic Aftermaths.” This book manuscript examines the modernist and postmodernist literary construction of traumatic memory in two cultural milieus, Israel and the Caribbean, characterized by small societies, enmeshed intercultural connections accompanied by relative geographic isolation, and recent histories of acute social violence. I argue that the filial agonism of modernists and postmodernists in these societies assumes a highly politicized character because the oppositional ethos of the older generation of modernists was predicated on essential notions of identity that a younger generation rejects as inadequate to emergent traumatic narratives. The project seeks to address a profound scarcity of literary studies encompassing comparative structural relations by researchers with adequate transcultural training and linguistic skills. At the same time, the book aims to appeal to a wide scholarly audience insofar as it spans the discourses of postcolonialism, the Holocaust, and recent theories of trauma and nationalism.

Thesis: The works of Aharon Appelfeld and Édouard Glissant present a challenge to collective representational codes that achieved dominance prior to the Second World War within their respective societies, Israel and Martinique. Responding to the Modernist emphasis on ‘return’ that is evident in both the Césairean theme of *retour* and in neo-Romantic Hebrew literature’s nostalgia for origins, Glissant and Appelfeld formulated distinctive literary idioms that are unexpectedly comparable in their use of the figure of repetition. The dislocating but potentially

transformative figure of repetition signals, in their writings, history's haunting force in the postcolonial and post-*Shoah* conditions.
